General Acceptance Conditions Plastics Coolrec

These acceptance conditions apply for location; Coolrec Plastics Waalwijk

- 1. Coolrec processes plastics from white and brown goods, to mention:
 - a. Household and professional cooling equipment
 - b. Display equipment
 - c. Other white and brown goods, incl. consumer electronics and industrial metal/plastic combinations
 - d. Monostreams
- 2. The offered plastics that has to be processed must be notified in writing to Coolrec in advance. This can be done via the data mentioned in the contract.
- 3. If the provider provides the transport himself, he has to use an authorized transporter who makes use of proper transport.
- 4. All incoming and outgoing material flows must be weighed on the calibrated weighbridge of Coolrec Plastics Waalwijk. Only these coupons are accepted.
- 5. Unless explicitly stated in advance, al shredding must be delivered in bulk. The material must be delivered in containers or walking floors. Or if agreed otherwise.
- 6. Prices mentioned in correspondence are only valid if the products supplied correspond with the information you provide. If the delivery differs, Coolrec will have the right to adjust the prices.
- 7. All shipments must be provided with fully completed transport documents, including an internationally valid shipping note. In addition, under applicable EVOA legislation, notifications may be necessary (orange or green list procedure). Shipments without completed transport documents (including accompanying letters) cannot be accepted. The competent authority will be informed of this.
- 8. Acceptance of a shipment takes place by signing the transport documents and/or accompanying letter by Coolrec. A copy of this remains with Coolrec.
- 9. A visual inspection will take place in the first instance upon receipt. An acceptance can only take place when unloading. Coolrec reserves the right to reverse the acceptance at a later

date, this i.v. processing the product. Coolrec then conctacts the provider to come to a solution. If Coolrec has to incur extra costs for this, this will be communicated with the provider.

- 10. The offered plastic that has to be processed, must be free of moisture, dirt and harmful materials that impede good processing and/or good end product. In this case the freight is not accepted, see table 1, table 2 and table 3.
- 11. Supplied plastic must match the contracted plastic. Plastic for which no price agreement is based, will not be accepted.
- 12. The provider will always be contacted about the unauthorized plastic to come to a solution. If it concerns a license load, the competent authority is informed about it. If there is no agreement, the non-accepted delivery will be returned at the expense of the provider.
- After the offered shredder has been accepted, an invoice is sent by the supplier of Coolrec to the address specified in the contact
- 14. If Coolrec suspects in any way that there is a violation of the law, a declaration is made to the competent authority.
- 15. The delivery times for location Coolrec Plastics Waalwijk are as follows:
 - a. Between 07.30 and 15.30 am from Monday to Friday unless otherwise agreed.
- 16. The delivery address is as follows: van Hilststraat 7, 5145 RK, Waalwijk
- 17. If you deviate from the day and/or time, you must make an appointment with the responsible logistics.
- The supplier of the waste must reasonably assess whether the waste contains Substances of Very High Concern.
- If a waste contains Substances of Very High Concern (SVHC), the supplier must inform Coolrec in advance about the name of the ZZS substance(s) and the amount of ZZS present in % m/m.
